 It had still not been possible to contact with Mr Sheath of the Football Club. The

A meeting had been held with the Bereavement Officer to discuss the state of the cemetery and the possibility of a Friends organisation. He would be willing to attend the November Parish Council meeting to discuss further with residents. Some action had been taken to implement the grounds maintenance contract conditions.

THE WAY: TO AGREE ADVERT RATES FOR 2022, AN HONORARIUM FOR THE EDITOR AND GIFTS TO VOLUNTEERS, AND A PRIZE FOR WROXALL SCHOOL COVER DESIGNS

After discussion it was resolved that there be no increase in advertising rates for 2022. It was also agreed that an honorarium of £150 each be provided to Mrs Gallop and Mrs Chilton in recognition of the excellent voluntary work they put in to keep the magazine running. A budget of £260 was set to provide Christmas gifts to the volunteers who distributed the magazine. It was agreed that the school competition should proceed with two age ranges and that the Parish Council purchase art-based prizes locally with a budget of around £50.
